It was clarified that the bond amount varies from year to year, but the local option tax rate does not change, and historically has not changed in 20 years.

Mark Christie moved and Don Hedrick seconded that the Budget Committee of Sisters School District approve the budget for the 2023-2024 fiscal year in the amount of \$68,021,134. Vote was unanimous in favor. Motion passed 9-0.

Don Hedrick moved and Kristin Turnquist seconded that the Sisters School District Budget Committee approve taxes for the 2023-2024 fiscal year at the rate of 4.0997 per \$1,000 of assessed value for operating purposes, .75 per \$1,000 in local option taxes and in the amount of \$3,331,860 for payment of bond principal and interest. Vote was unanimous in favor. Motion passed 9-0.
