Mark Christie moved and Don Hedrick seconded that the Budget Committee of Sisters School District approve the budget for the 2024-25 fiscal year in the amount of \$34,449,657. Vote was unanimous in favor. Motion passed 9-0.

Mark Christie moved and Rob Corrigan seconded that the Sisters School District Budget Committee approve taxes for the 2024-25 fiscal year at the rate of 4.0997 per \$1,000 of assessed value for operating purposes, .75 per \$1,000 in local option taxes and in the amount of \$3,454,882 for payment of bond principal and interest. Vote was unanimous in favor. Motion passed 9-0.
