CALL TO ORDER / FLAG SALUTE

SUPERINTENDENT REPORTS

Bond Update Curt Scholl shared that a fan under the hood of an appliance is waiting to be repaired, which has

delayed final fire inspection. All else seems to be on track with final details, such as parking line painting, delivery of playground equipment and final furniture. The school should be all set to open for

the start of the school year, unless there is an issue with final inspections.

Old SES Occupancy Update Curt Scholl shared that due to regulations, SSD cannot lease to multiple organizations without a great

amount of additional administration. However, SSD can lease to SPRD as a "Community Center", and then SPRD can sublease to multiple organizations who fall under the category of community support. This is now being put in place, and both Treehouse Therapies and a childcare center are working on

contracts with the SPRD. Move in has begun for certain entities.

Workforce Housing Update Curt Scholl shared that the ribbon-cutting ceremony took place in July for the first workforce housing home and the selected teacher has moved in. The second workforce housing home is still on the table

with hopes that interest rates will soon decline, which should allow more SSD staff to pre-qualify.
